SERVICE DEFINED

Generally tracking is the observing of persons or objects on the move and supplying a timely ordered sequence of respective location data to a model e.g. capable to serve for depicting the motion on a display capability.

Tracking companies provide total visibility and control of mobile assets, using technology of Global Positions system (GPS), Global System for mobile communication (GSM), General Packet Radio Service (GPRS),

What is GPS:

The Global Positioning System (**GPS**) is a technical marvel made possible by a group of satellites in Earth's orbit. It transmits precise signals, allowing **GPS** receivers to calculate and display accurate location, speed, and time information to the user.

What is GPRS:

General Packet Radio Service (GPRS) is a packet-based mobile data service on the global system for mobile communications (GSM) of 3G and 2G cellular communication systems.




HOW TRACKING DEVICE WORKS

GPS satellite send location, speed and heading of the vehicle to the controller unit located in the Vehicle

When requested, the controller unit retrieves the GPS data and send it to the wireless service provider network using th GPS receiver The Wireless service network forwards the notifications and location data received from the controller unit to the central fleet server using SMS/GPRS or to any mobile phone.

A web based interface allows graphical tracking of your entire fleet as well as receiving notifications via emails or SMS on your mobile devices.


