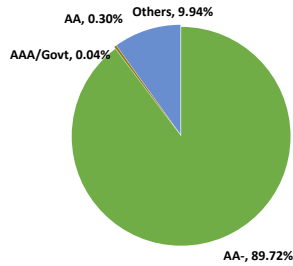

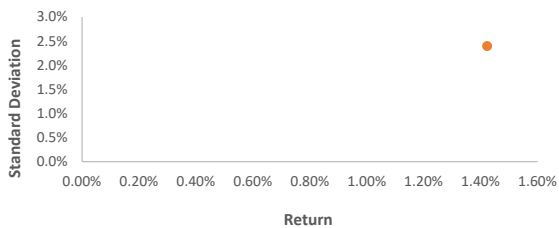

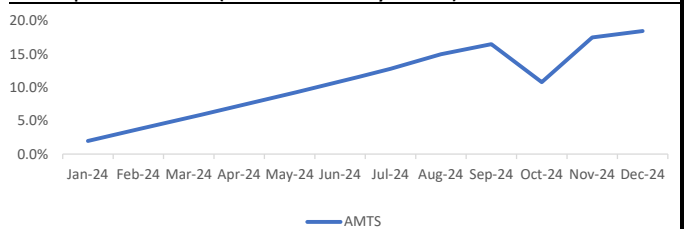

#### Commentary

As of December 2024, Alfalsh MTS Fund (AMTSF) reported an AUM of PKR 88 million, reflecting a declining trend due to investor redemptions and liquidity-driven adjustments. The fund has significantly deviated from its stated objective, eliminating its MTS exposure (previously 71.31% in June 2024) and reallocating primarily to AA-rated instruments (89.72%), with increased holdings in "Others" (9.15%). The WAM stands at 0 days, a sharp decline from 40 days in March and 44 days in June 2024, reflecting a shift towards ultra-short-duration holdings. Performance-wise, the fund posted a 1.7% return in Q4 2024, lagging behind the peer average of 2.9%, while its FY24 return of 18.5% remained close to the peer benchmark of 18.8%. The fund's volatility (2.4% standard deviation) exceeded the peer average (0.9%), highlighting elevated risk exposure. If this strategic shift persists, a reassessment of the fund's rating may be warranted, given its divergence from the original investment mandate and evolving risk-return dynamics.

**Going forward, any material changes in the funds asset allocation strategy, which could impact the funds credit quality and exposure to interest rate risk, remain critical for the rating.**



# Stability Ratings Explained

The Stability rating is based on a detailed quantitative assessment of fund's portfolio and qualitative assessment of fund management. It provides the investors with an objective measure as to the main areas of risk to which the income funds are exposed, which is credit risk, liquidity risk and interest rate risk.

<b>Credit Risk</b>	<ul style="list-style-type: none"> <li>The foremost factor is credit risk, having the highest weight in the rating matrix. The opinion is based on review of various factors, including the fund's investment policies regarding credit risk exposure towards various market segments, individual and cumulative credit quality of the investment portfolio, the diversification of assets across investment types and issuers, and weighted average maturity.</li> </ul>
<b>Market Risk</b>	<ul style="list-style-type: none"> <li>The more complex part of evaluating a fund's stability involves determining the fund's sensitivity to the changing market conditions. PACRA assess market risk in the nexus of variables affecting the market value of the underlying portfolio. Market value can fluctuate due to a number of variables largely including interest rate, liquidity and operating environment.</li> </ul>
<b>Liquidity Risk</b>	<ul style="list-style-type: none"> <li>The liquidity of a security refers to the speed at which that security can be sold for approximately the price at which the fund has it valued. Securities which are less liquid are subject to greater price variability. While analyzing the liquidity of investment portfolio, PACRA considers the types of investments in the portfolio, the maturity structure, and secondary market liquidity.</li> </ul>
<b>Historical Returns Volatility</b>	<ul style="list-style-type: none"> <li>Funds having operational history of six-months or more, the variability in returns is gauged on standardized basis through coefficient of variation for each fund in a category. The coefficient of variation is calculated by dividing standard deviation of fund's monthly returns by average monthly return (SD of Monthly Returns/Average Monthly Return).</li> </ul>
<b>Asset Manager</b>	<ul style="list-style-type: none"> <li>Management scoring is derived from the asset manager rating of the company managing the fund. PACRA reviews the policies and procedures developed by the management to meet its investment objectives. Therefore, an assessment of the fund manager's qualification and experience, asset management company's capabilities and track record are an integral part to the fund rating process.</li> </ul>
