### PACRA withdraws rating of TFC Issued by TPL Trakker Limited

The Pakistan Credit Rating Agency Limited (PACRA) has withdrawn the rating of TFC (PKR 200mln) issued by TPL Trakker Limited ['A' (**Single A**)] subsequent to the completion of the redemption process . The instrument was due for final redemption on September 15, 2011. The issuer and the trustee (First Dawood Investment Bank) have confirmed that TFC has been fully settled in an orderly manner.
